TERMS OF BOOKING MOBIL-HOME and PITCHES

Any reservation becomes effective only with the agreement of Camping Val d'Hérault, after receipt of the deposit amount of 50% of the total amount of your stay (including 12 euros booking fee and excluding local taxes) and upon receipt of the booking form duly completed and signed. The reservation is personal and valid for one pitch or rental. Minors must be accompanied by their parents or an adult. Pets are welcome with a fee payable on arrival. We reserve the right to refuse access to the campsite to groups or families with a higher number of participants to the capacity of the rented accommodation. The balance is due upon arrival. In case of need for planning, management reserves the right to change the rental number or location.

CANCELLATION MOBIL HOME Camping Le Val d'Hérault offers an optional Cancellation & Interruption in your lease. Our Affinity Gritchen partner undertakes to reimburse all or part of the stay only to customers who purchased the insurance Covered Camp. If canceled, notify the campsite of your cancellation upon the occurrence of an event preventing your departure by mail or email. If the loss is expected in the general conditions (available on the website www.campez-couvert.com or from the campsite), notify the insurer within 48 hours and provide all the necessary information and supporting documentation. This insurance must be taken when making the reservation and payment of the deposit and will in no way be subscribed later. In case of no underwriting this insurance no refund will be granted in case of cancellation, no show, early departure or other unforeseen.

CANCELLATION PITCHES Off season: Any cancellation or anticipated check out must be reported to the front desk within 24 hours the arrival. Peak season: The Val d'Hérault does not refund nor a deposit nor a booking from the 1st of July to 31st of August.

CAMPING PITCH Maximum number of people per pitch is 6. For all groups over 10 people and up to 30 people in place, a deposit of 400 euros will be requested when booking and retained by the campsite if not -respect the rules of procedure. For groups over 30 persons the deposit will amount to 900 euros. Arrival is from 15 hours and pitches must imperatively be released for 12 hours.

RENTAL Keys check in from 15 pm until closing time of reception desk. In case of late arrival inform us. On arrival is due the balance of your stay regulation, an 2 deposit are required: one of 200 € for rental home and one of € 90 in deposit of end cleaning. In addition to this, for all groups of over 10 people and up to 30 people, a security deposit of 400 euros will be requested when booking and retained by the campsite in the event of non-compliance of the rules. For groups of over 30 people, the deposit will amount to 900 euros. The cleaning of the property is your responsibility and any breakage or damage shall. We provide a cleaning service at end of stay € 70. Deposits will be returned after inventory of fixtures if nothing is reported. The day of departure the rental must be released for 10 hours. In July and August, rental bookings run from Saturday to Saturday.

RULES OF PROCEDURE OF THE CAMPING VAL D'HERAULT

HOME AND ELIGIBILITY The facility is open to the public from 19 March to 31 October. This induces that nobody will be allowed to enter the premises outside this period. During the opening of the campsite, the opening hours are posted at the entrance of the office and on our website. According to Article 1 of the decree of 7-02-1959, no person can be accepted on the campsite without the agreement of the manager or his representative. The fact of staying on the campsite "Le Val d'Hérault" implies acceptance of the provisions of these rules and the commitment to comply. Any person wishing to stay at least one night on the camp must report to manager or reception office to present his identity papers and complete immigration formalities. The minors remain the responsibility of the parents present at the campsite. Wearing the bracelet campsite is compulsory in July and August.

INSTALLATION Camping equipment must be installed as shown by the staff of the campsite. Everyone is obliged to refrain from any action that might prejudice the cleanliness, hygiene and appearance of the campground and its facilities. Any damage to vegetation, fences, land or facilities of the camp will be the responsibility of its author. The location that has been used during the stay will be in perfect condition upon departure, particularly in clean condition. It is forbidden to the camper to delineate the location of a facility by personal means, to dig the ground, to drive nails into trees, to cut branches, to make plantations. In case of obvious discomfort, please report it to the reception. It is forbidden to throw wastewater on the ground and in plantations; washing is strictly forbidden outside the bins provided for this purpose; it is forbidden to wash the car inside the campsite; the spreading of the laundry will never happen from trees or plants guardians; The chairs and tables of field facilities, inventory items of mobile homes, locations, numbers should not be moved to any other location. It is forbidden to work on the electrical installations of the campsite. Caravan: It can not be left equipment on site.

COURTESY RULES Campers must avoid any noise, all games or any discussions that might disturb their neighbors after 11 p.m.. The sound equipment must be adjusted accordingly, closures chests and doors as unobtrusive as possible and in general, any use of any material whatsoever. For hygiene reasons, animals must be left outside the campsite for their natural needs. Cats and dogs must be on a leash and do not wander about the camp. They must be tattooed and vaccinated and presentation of vaccination book will be systematically requested at reception.

VISITORS Visitors are admitted to the campsite under the responsibility of the campers who receive them and who have so requested at reception. They are then required to settle a fee per visitor and wearing the bracelet "visitor". Their vehicle must be parked on the parking at the entrance of it. **SAFETY** For safety reasons, fires or natural barbecues are strictly forbidden at the campsite. It is essential to provide a water reserve of at least five liters nearby. In case of fire, it must notify the manager immediately. Camping Le Val d'Hérault is in no way responsible for thefts committed on the ground. In an accident, an essential first aid kit is located at the reception. The play areas are in the custody of parents civilly and criminally responsible for their children when they use the games. No violent or disturbing game will be organized within the campsite. The campsite declines all responsibility for the land and water play areas. Swimming pool or river is not monitored. In case of bad weather, the campsite can not be held responsible for the caused damage.

TRAFFIC AND PARKING OF VEHICLES Inside the camp, the vehicles run on not. Only one vehicle is allowed per site. Can move about as those belonging to campers staying. Traffic is prohibited between 11:00 p.m. ET 6:00: No vehicle is allowed to enter or leave during this period, the gates are closed, while the vehicle is parked on the parking lot. Parking is on the site of the camper. Are allowed to park at a respectable distance from the river only campers with a "beach" location. In no case the vehicle shall not obstruct traffic routes or prevent the installation of new arrivals.

MISCELLANEOUS Fishing is only allowed with a permit. The caravans can install a canvas awning or a removable front or side. It is forbidden to put two. The locations will only be for recreational use, to the exclusion of all industrial, commercial, craft or professional or general. Users will under no circumstances take up residence, camping is a leisure activity. The acceptance of this Regulation is authorized for camping use any photographic support of the campers would be

used for promotional or advertising purposes. Glass containers, packaging and paper are installed in front of the reception desk: have ecological gesture, sort and bring it to throw your materials. The team of Camping Le Val d'Hérault wish you a pleasant stay.
